





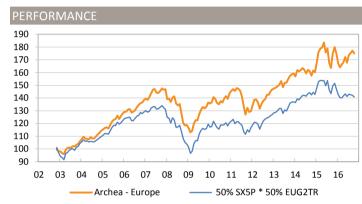

FUND MANAGER'S COMMENTS

Most European indices declined in October. The Eurostoxx 50 Index (SX5P) fell by 1.05% and the Bond Index (EUG2TR) by 0.82%. As a result, the NAV of our fund fell by 0.58%. The contrasting results of the third quarter negatively influenced the indices. Currently, companies can no longer be satisfied with meeting their objectives, they must realize them.

During the month of October, we participated in the Air Liquide capital increase and added Geberit as a new value to our portfolio.

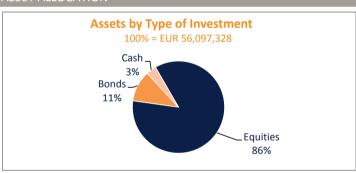
Outlook: Everything will depend on the outcome of the U.S. presidential election which highly disputed for the moment. In the meantime, the markets are very volatile. After the elections, we will look for stocks that are likely to perform well in the future according to the political agenda of the new president. Finally, caution should be exercised with regard to bonds. Indeed, the recent rise in bond yields does not encourage us to increase our positions.

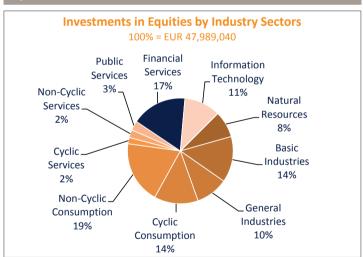

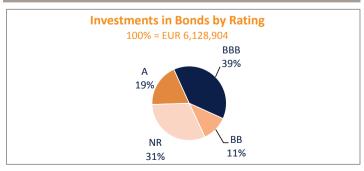
