

FUND MANAGER'S COMMENTS

In the last days of August, the indices suffered a serious drag on the background of the revival of the trade war between Washington and Beijing and concerns about Italy. Against this backdrop, the benchmark SX5P fell 3.88% in August and our fund was down slightly by 0.24%. Over the month, we took out *Henkel AG* and replaced it with *Alstom SA* and *STMicroelectronics NV*.

Outlook: September is always a crucial month. Confidence in Europe seems to be affected with the escalation of trade measures announced by Donald Trump and uncertainties about Italy's financial health. However, we remain positive about equities. As a precaution, we will ease some positions to create liquidity.




