**FUND MANAGER'S COMMENTS**

The October was again a positive month for the markets. With an increase of +1.11% for the Eurostoxx 50 and +2.17% for the S&P 500 (in USD), the indices posted new records.

Relations between China and the United States have improved considerably, both countries have found an agreement on the "phase 1" of a partial trade deal. With 128,000 jobs created over the month, employment data are still positive in the U.S., although the unemployment rate has risen very slightly. The manufacturing sector is contracting, and profits continue to decline. On the other hand, the yield curve is "re-steepening". In Europe, E.U members agreed to ultimately extend the Brexit deadline until 31 January 2020, it seems we are close to a deal. In Japan, the increase of the VAT from 8% to 10% could affect household consumption. The world economy continues to slowdown; the IMF has revised its forecast for 2019 from 3.2% to 3.0%.

Globally, uncertainties are still present, which requires central banks to maintain their accommodating monetary policies. Fed has lowered its rate by 25 bp, for the third time this year, to reach a range between 1.50% and 1.75%. Mrs Lagarde became President of the ECB, with the aim of renovating the institution.

The Spectrum fund rose by +0.16% over the month. The **BL Global Flexible** fund was the main performance contributor, mainly due to its holdings in bonds and gold.

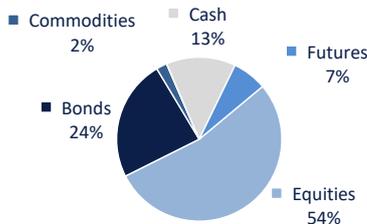

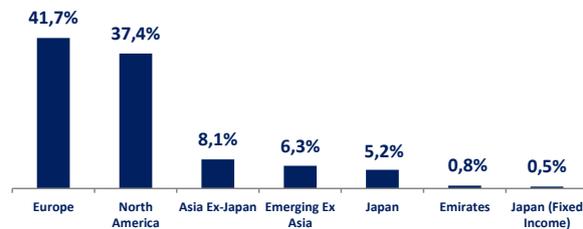

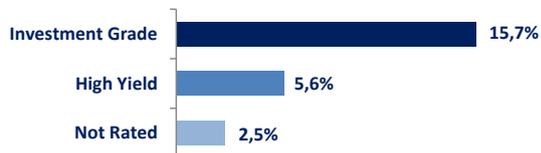


**GEOGRAPHICAL ALLOCATION**

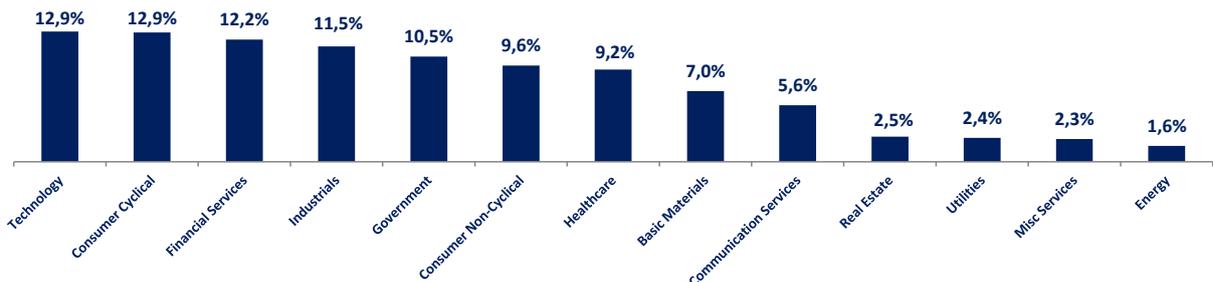
