## Objectives and investment policy

### Objectives

To seek capital appreciation by investing in equities.

### Investment policy

The sub-fund's net assets are primarily invested in the shares of companies that have their headquarters or their core business in the United States of America.

The sub-fund also has the possibility to invest, on an ancillary basis, up to a maximum of 10% of its net assets in UCITS and/or other UCIs that are in turn investing in equities, in order to achieve its objective and with a view to investing its cash.

According to market conditions, the sub-fund may invest, on a temporary and ancillary basis, up to 100% of its net assets in money market instruments, within authorised legal limits.

The sub-fund may use derivatives in order to hedge against the consequences of adverse market developments on the sub-fund's portfolio or to optimise the

sub-fund's performance.

The portfolio is actively managed on a discretionary basis without using a reference benchmark.

The currency of the share class is expressed in USD.

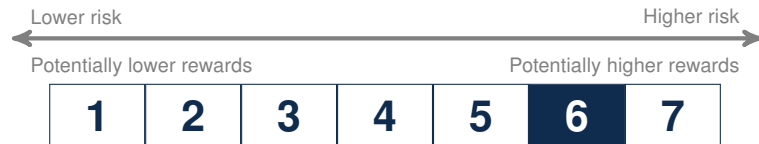
The investor has the right to redeem his shares on demand. The dealing in shares is carried out on each complete bank business day in Luxembourg. The attention of the investor is drawn to the fact that in exceptional circumstances, the possibility for the investor to request the redemption of his shares may be limited or suspended.

These shares are capitalisation shares. Income and capital gains are reinvested.

### Recommendation

This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

### What does this synthetic indicator mean?

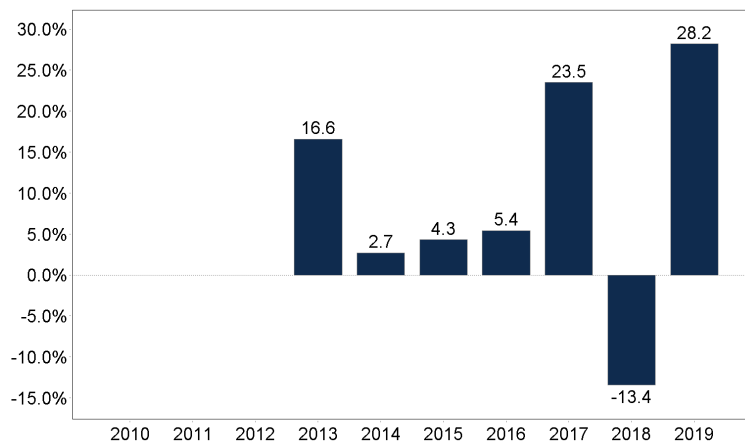
