
FUND MANAGER'S COMMENTS

The month of September turns out to be negative. The Eurostoxx 50 index (SX5P) ended down -1.71% and our fund by 1.13%. This month was characterized by larger profit taking in the markets by investors who fear a rapid resurgence of the health crisis. It's noteworthy that banks and energy experienced severe declines which significantly affected performance.

ARCHEA FUND | Europe

During the month of September, we have added Shop Apotheke Europe N.V. in e-commerce to our portfolio.

Outlook: We remain constructive on equities in the medium term. The upside potential for eurozone equities does not appear to be exhausted, despite the recovery seen from their March lows. However, it will be necessary to take into account the one-off risks such as the evolution of the pandemic, the US elections and the geopolitical tensions that will weigh on the markets in the short term. In choosing values, we must also consider that we are in a world of green growth.
