

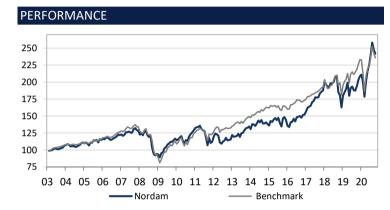

## INVESTMENT APPROACH

The fund aims to deliver a total return in terms of USD as high as possible. The fund invests worldwide in equities, securities with fixed or variable interest rates and money market instruments.

## **FUND MANAGER'S COMMENTS**

Over the month, the fund's NAV decreased by -2.28%. At first, stocks continued their positive run since summer, but during the last week of October deteriorating health conditions and partial lockdowns in several European countries weighed on markets. The coronavirus epidemic has gained the upper hand again, triggering another bearish wave. The most marked declines were in the technology, energy and health sectors. On the other hand, the release of Q3 results led to profit taking in the tech sector, but it continues to benefit from the digital transformation of the economy. Under fears of another economic downturn, oil prices once again got under pressure. US equities are benefiting from a dynamic earnings outlook and the adoption of a new stimulus package should help maintain a sustained level of consumption despite more difficult employment conditions. Economic activity is expected to remain robust enough to translate into a rather dynamic earnings recovery in 2021. The current correction should be seen more as increased volatility, with central banks remaining accommodative.

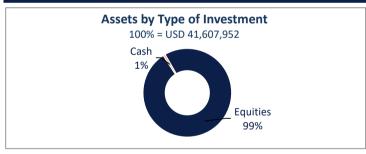


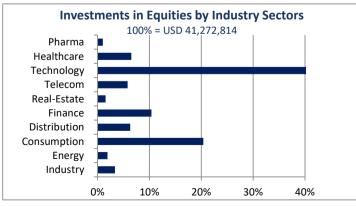
