What is this product?

Type

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

Term

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

Objectives

Seeks capital appreciation by investing in securities of companies considered innovative (in the opinion of the manager) in the Asia region and, to a lesser extent, in the Pacific region.

The sub-fund will invest at least 60% of its net assets, directly and/or via American Depositary Receipts ("ADRs"), in equities whose registered office or main activity is in Asia. The sub-fund may invest up to a maximum of 30% of its net assets in shares of Chinese companies via the stock exchanges of Hong Kong, Singapore, London, New York and/or via ADRs. The sub-fund may invest up to 40% of its net assets in shares of companies whose registered office or main activity is in Australia and/or New Zealand.

Depending on market conditions and/or opportunities, the sub-fund may also invest up to a maximum of 20% of its net assets in contingent convertible bonds.

The sub-fund may hold cash on an ancillary basis. In exceptional market circumstances, the sub-fund may temporarily hold more than 20% of its net assets in cash and/or term deposits, fiduciary deposits and/or money market instruments.

The sub-fund may also invest up to 10% of its net assets in UCITS and/or other UCIs, in accordance with its investment policy.

The sub-fund may, within the limits defined by law, invest in derivatives, including warrants, for hedging purposes or for optimising portfolio management.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

This product is designed for investors seeking income and capital growth with a medium to long term perspective (at least 4 years). The investor may incur losses up to the amount invested. This product is suitable for investors with basic to advanced product and market knowledge and experience.

Other information

Depositary: Banque de Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money

because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

The sub-fund is also exposed to the following materially relevant risks that are not included in the summary risk indicator: Geographical concentration risk, underlying investment risk, other risks.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

What happens if ARCHEA FUND is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
- 10,000 USD is invested

How long should I hold it and can I take money out early?

Recommended holding period: 4 years
