What is this product?

Objectives: The objective of the Fund is to achieve long term capital growth. The Fund is mainly investing in convertible bonds or similar financial instruments issued by companies from around the world. In addition, the Fund may hold bank deposits as well as invest in other funds or money market instruments.

Intended retail investor: In the member state of origin, the product is intended for Professional and private investors with a long-term investment horizon, Informed experience and who are able to bear a full financial loss. The product may be used for capital appreciation.

What are the risks and what could I get in return?

Risk Indicator:



The risk indicator assumes you keep the product until 8 years.


Recommended holding period: 8 years
