What is this product?

Type

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

Term

This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

Objectives

Aiming for long-term capital increase by giving investors access to mixed management strategies entrusted to teams of experienced managers.

The sub-fund invests predominantly in investment funds that invest in equities and/or debt securities, without any limits in terms of location, sector or currency.

The remaining sub-fund assets may be invested in:

- floating-rate equities and/or debt securities, including in emerging markets
- fixed-interest debt securities
- money market instruments

The percentage of the portfolio invested in the various instruments included within the remaining assets may vary depending on the instruments' value and market conditions.

The sub-fund may hold cash on an ancillary basis. In exceptional market circumstances, the sub-fund may temporarily hold more than 20% of its net assets in cash and/or term deposits, fiduciary deposits and money market instruments, directly or indirectly through UCITS, ETFs and/or other UCIs that are themselves invested in money market instruments.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

This product is designed for investors seeking income and capital growth with a medium to long term perspective (at least 4 years). The investor may incur losses up to the amount invested. This product is suitable for investors with basic to advanced product and market knowledge and experience.

Other information

Depositary: Banque de Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

What happens if ARCHEA FUND is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. Recommended holding period: 4 years

Redemptions are possible on each full bank business day in Luxembourg. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
